Bike Safety







Several neighbors have expressed concern for the safety of children on bicycles, scooters, etc. in our area.

Safe cycling guidelines recommended by the Nebraska SAFE KIDS Program include:

- Purchase an approved bicycle helmet for each child and adult. Insist the helmet is worn correctly every time the child goes for a ride. Parents/caregivers need to wear helmets as well. Only buy helmets that meet or exceed safety standards developed by the U.S. Consumer Product Safety Commission.
- Teach children safe bicycling behaviors. More than 80 percent of bicvcle-related fatalities are associated with the child's behavior, including riding into a street without stopping, swerving into traffic that is

coming from behind, running a stop sign, and riding against the flow of traffic.

- Make sure the child's bicvcle works properly. Are reflectors present and secure? Test the brakes, gear shifts and tires.
- Familiarize yourself with the child's bicycling environment. Encourage the child to bike in safe environments, such as those with bicycle paths.
- Have your children wear bright colored clothing so drivers can spot them more easilv.

Enforcing Covenants

The homeowner's association board receives between 5-10 covenant violations/concerns monthly.

That correlates to between 5-20 hours spent to investigate, document, call or send a letter, and follow-up to ensure the issue was resolved.

The most common complaints are:

- Boats, trailers, campers, and vehicles being stored on lots, driveways, or streets
- Trash cans being stored in open view
- Yards/lots not being maintained, e.g., Mowing frequency, weed control.
- Businesses being run out of a home

- Non-approved fencing, e.g., chicken wire, metal
- Barking dogs

Suffice to say, handling complaints from neighbors is not a board member's favorite task. But, we have received positive feedback that, since the inception of the homeowner's association, the quality of the neighborhood has improved as a direct result of enforcing covenants.

Please be considerate of your neighbors and adhere to the Torrey Pines neighborhood covenants.

Some neighborhood issues are out of the jurisdiction of the Homeowner's Association and fall under the SID (Sanitary Improvement District) umbrella.

The Torrey Pines Homeowner's Association works closely with the SID to work through many issues.

For instance, you may have noticed the bike path on the north side of Torrey Pines has been mowed. A new contractor was hired to keep our side of the bike path in shape and new trees have replaced dead ones.

The SID is also planning to install 4 speed tables in our neighborhood to help with traffic calming. Two speed tables are planned for 150th street, and two for 153rd street. We hope to have these installed in the fall.

No Parking signs with time constraints will be appearing along 153rd to help alleviate the commercial overflow parking situation plaguing the homes along that street.

The SID also provides consultation to the TPHOA regarding legal issues and covenant violations.
