Secondly, the cooperation of the homeowners that are in violation has been very good for the most part and for that I thank those that have worked with us. There are some who seem to ignore our requests for cooperation. As a result, we are looking into the option of assessing fines, liens and other suitable measures as have been defined in the original covenant declaration. We are conducting meetings with other Homeowners Associations to get a general consensus as to how they are addressing like issues in their area. More details will be provided at the public meeting in May.
