#### Pools

The Torrey Pines Homeowners Association Covenants strictly prohibit above ground pools. The bottom line is that as homeowners, we recognize your desire to stay cool in the summer. However, keep in mind above ground pools are not allowed. This decreases the value of your home and your neighbors. As a Board, we are keenly aware of the number of incidents around the metro that happen every year. Beyond a violation, we are also concerned about safety and health of all of our neighbors. Many of our homeowners upon notification don't realize not have had a pool accident. Waiting this is a violation and act quickly to resolve the issue. Still others continue to ignore our request to adhere to our covenants. Please take note, as a Board, we will take appropriate action to ensure compliance to No temporary structure of any character. this item.

#### **Covenant Reminder**

Every year your homeowners association

receives a number of complaints. The majority of the received complaints over the past few years can be categorized into several specific covenant areas. As a courtesy to your neighbors please keep the following covenants in mind:

#### Article 1.8

No boat, camper, trailer, auto-drawn or mounted trailer of any kind, mobile home truck, aircraft, camper truck or similar chattel shall be maintained or stored on any part of Lot (other than in an enclosed structure) for more than twenty (20) days within a calendar year.

#### Article 1.9

No garbage or trash can or container shall be permitted outside, except for pickup purposes. Please stow your trash receptacles as soon as reasonably possible.

#### (Covenant Reminder Cont.) Article 1.12

No swimming pool may extend more than one foot above ground level. We receive a number of calls about aboveground pools every year. Whereas we recognize that many families with children will often use small wading pools, please keep in mind that beyond a covenants violation, there are safety concerns when these are used and maintained without adequate fencing securing the pool from those who may wander in to use your pool. Torrey Pines has been very fortunate to until after one happens will be too late and very tragic for some family.

#### Article 1.19

and no carport, trailer, open basement, storage or tool shed shall be erected upon or used on any Lot at any time, either temporarily or permanently.



### Watering Tips Soon the hot and dry

weather will be with us and with that comes the frequent watering of our thirsty lawns, but are you

getting the most out of each watering session? If you are able to observe water runoff, then any additional watering is to no avail. To get the greatest benefit, try these simple tips:

- Shorten the watering times and increase the frequency. If you notice
  - \* runoff after a 40 minute interval. trv changing the station time to 20 minutes and after all zones are finished, start again at the beginning. Two 20 minute sessions will water more deeply than one 40 minute session will.

#### Watering Tips (cont.)

- Add gypsum. This additive to your lawn will assist in the penetration of compacted soil for a better result.
- Avoid overwatering your trees in the process. If young trees are in the path of your sprinklers, you could end up killing them through overwatering. This is the single most cause for tree mortality.
- Be considerate of your neighbors when scheduling watering times and intervals. It is somewhat annoying to start mowing only to end up getting showered by a neighbors sprinkler before you can complete the task. Also, try and avoid turning the downhill neighbors lot into a swamp. They will appreciate that.

These measures will help you get the most out of every drop.

#### Mayor's Hotline

Now that we are part of the city, we are beginning to realize many of the benefits associated with our tax dollars. Many of us have realized a very substantial drop in our property taxes vs. the amount we paid under the SID.

One of the benefits is the Mayor's Hotline. If you have issues involving city services,



such as snow removal, overgrown lots, bike path mowing, trailer storage and vehicles in dead storage (to name a few), take action and call the Mayor's Hotline at 444-5555. Many of the City of Omaha ordinances overlap with our own covenants and city enforcement is available. If you are an affected property owner, your call gets the highest degree of consideration and they really do respond.
