## III. Approval of 2024 Minutes-John Gocken

## IV. President's Report – Michael Classen

2024 Highlight: Tree trimming was the major concern addressed.

Planned for 2025:

- Spring cleanup focused on beautifying islands (mulch, rocks, etc.)

- Sprinkler system and back-flow valve replacement Michael will handle replacement.
- Uriel from International Lawn and Landscaping will continue neighborhood maintenance.
- Bids being collected for mulch wanting at least three.

#### V. Treasurer's Report – Christy Kofoed

Presented the current budget.

No specific events planned due to budget constraints.

#### VI. Community Relations - Jen Johnson

Limited budget presents challenges with planning events.

- Will explore 4th of July bike parade, in or to the park.
- Would like to do an Ice cream social, if budget allows.

Reminder that all Dogs must be kept on a leash while walking.

#### VII. Sage HOA Services Update – Joe Schmidt

Explained Sage's role and services in response to homeowner questions.

Fining standards:

- HOA board has authority to fine per bylaws. Sage performs random monthly inspections for any potential violations. Letters and fines may be sent out based on those inspections.

- 2–3 project approval requests handled monthly.

- Approvals are based on maintaining neighborhood aesthetic and meeting covenants expectations.

#### VII. Committee and Homeowner Discussion

Homeowner Concerns:

- Retaining wall on Taylor Street is deteriorating; may fall under city's responsibility due to sidewalk adjacency.

- Speed-bumps off 150th Street are causing drainage issues during rain.

- Report submitted to city for dangerous bolt at park; child injured.
- Old farmhouse at 150th & Maple inquiries about future development.
- Five cars regularly parked on Sprague street in Westin Hills pose safety concerns.

- Trash cans left out – minimal complaints. Homeowners can request fencing enhancements, by submitting a project request to Sage for review.

### **VIII. Elections-Vice President**

Vice President position was up for re-election.

No new nominations.

Bryan Stavneak re-elected unanimously.

#### **IX. New Business**

- Speed-bumps on 150th Street causing water pooling; will continue working with city.

- Vegetation overgrowth on islands off 150th Street; Uriel will handle cleanup.
- Taylor Street lot (owned by Bryce) remains undeveloped; waiting on city updates.
- City plans to remove trees from 150th islands and replace with concrete.

- Semi-truck issue on Taylor: relocated near apartments. More photos will be submitted to the city.

- Sprague Street parking issues during Husker games and other events.
- Request made to pursue no-parking signs on 154th and Taylor Street.
