Homeowners Association Dues for 2015

All Homeowners received a paper mailed statement for the 2015 Dues the first week of December 2014. The 2015 dues in the amount of \$60 were due on or before 1/15/2015. Dues were considered "late" if they are not received by 2/1/2015. This interest fee of 16% was applied to any property that had not paid their dues by 2/1/2015. Liens were placed on properties on 2/15/15 and an additional \$21 for the lien filing fee was added to those account balance.

A BIG thank you to all of the home owners that continue to pay ahead and on time! We greatly appreciate your cooperation!

Out of the 157 homes in 2014 we only have 2 home owners that we have outstanding liens on their property.





Please make sure you make a note for 2016-the HOA fees are due on 1/1/2016, and considered late if not received on or before 1/15/2016. You will receive a 2016 statement in December of 2015.
