#### Homeowners Association Dues for 2016

All Homeowners should have received a paper mailed statement for the 2015 Dues the first week of December. The 2016 dues in the amount of \$60 will be due on 1/15/16. A second paper statement will go out to any homeowner that has not paid prior to 1/15/16 on 1/16/15 and the interest fee of 16% will be applied to the \$60 HOA fee. Homeowners that are not paid in full prior to 2/1/16, will have a lien placed against their property and be charged an additional \$21 lien filing fee.

For those of you that have already paid, we greatly appreciate it! Checks received for 2016 HOA fees will not be cashed until after 1/1/2016.
